Announcement from Bankadwittayakom School  
“No Gift Policy”

Bankadwittayakom School School realizes the importance of fostering organizational culture, values, and appropriate guidelines for personnels to strictly follow the No Gift Policy, to prevent actions that result in the use of power to benefit oneself or others, which is in accordance with the government's policy, along with the reform plan for the prevention and suppression of corruption and misconduct. In order to express such intention, Bankadwittayakom School realizes the importance of cultivating a sense of not accepting and not tolerating corruption, as well as fostering values, attitudes, consciousness, behaviors of teachers and educational personnel. Therefore, the No Gift Policy has stated as follows:

๑. Teachers and educational personnels of Bankadwittayakom School refrain from accepting gifts and presents of any kind from outsiders who come to contact the Office of Civil Service.

๒. Teachers and educational personnels of Bankadwittayakom School refrain from giving gifts and presents of any kind to outsiders who come to contact the government.

๓. Teachers and educational personnels of Bankadwittayakom School must not seek to obtain gifts, presents or benefits that are not in accordance with the law.

๔. Expressing congratulations, expressing goodwill, expressing welcome or expressing condolences on various occasions. According to normal tradition should be done by signing a greeting card, a guest book, a condolence card or using online social media to express instead of giving things.

๕. Teachers and educational personnels of Bankadwittayakom School have a duty to inform outsiders of the said policy in a comprehensive manner.
